# MEMBERSHIP LEVELS

**DANDY LION LITTLE LEAGUE CANNOT EXIST WITHOUT IT'S MEMBERSHIP.**

Here is a breakdown as to the different kinds of League Memberships and the requirements and benefits provided. We encourage the public to become **REGULAR MEMBERS IN GOOD STANDING** to help our league grow and maintain itself as a quality organization to benefit all of our children.

**Any PLAYER candidate meeting the requirements of Little League Regulation IV shall be eligible to compete for participation.** Player Members shall have no rights, duties or obligations in the management or in the property of the Local League.

**Any ADULT person actively *interested in furthering the objectives* of the Local League may become a **REGULAR MEMBER** upon approval by the Board of Directors and **PAYMENT OF:****

**YEARLY DUES IN THE AMOUNT OF \$10 TO THE LOCAL LEAGUE**

All yearly dues must be paid by personal check made payable to the Dandy Lion Little League

**Allocation of Dues:** All monies collected from yearly dues will be used to fund the Dandy Lion Little League's annual scholarship award(s).

**Any ADULT person who meets the qualification of a **REGULAR MEMBER**, as defined above, may become a **REGULAR MEMBER IN GOOD STANDING** if:**

- Agrees to **uphold the integrity** of the Local League
- **Parent or Guardian** of a Player Member in the Local League
- Must **FULLY PARTICIPATE** in the Local League's yearly major fundraiser
- May **not have been formally disciplined** by the Board of Directors

**Officers, Board Members, Committee Members, Managers, Coaches, and other elected or appointed officials **must be an active Regular Member in Good Standing.****

**Any ADULT person who meets the qualifications of a **REGULAR MEMBER IN GOOD STANDING**, as defined above, may become a **VOTING MEMBER** in the Local League, if the Regular Member in Good Standing **participates in Seven (7) Local League activities during the **REGULAR** baseball/softball season.****

**Four (4) of the Local League activities **MUST INCLUDE ATTENDANCE** at a regularly scheduled public board meeting.**

**LEAGUE ACTIVITIES MAY INCLUDE, but are not limited to the following activities:**

MONTHLY BOARD MEETINGS • COMMITTEE MEMBERSHIP  
ANY LOCAL LEAGUE DEFINED VOLUNTEER PROGRAM

**ONLY VOTING MEMBERS** are **eligible to vote** at General Membership Meetings.  
**ONLY VOTING MEMBERS **MAY BE ELECTED TO THE BOARD OF DIRECTORS.****
